In an effort to support Catholic school education, local Catholic parishes are offering a tuition grant up to \$800 per student to those parishioners who apply for the grant and are registered and participating members in that parish.

The Pastors of the Pensacola area have established the following criteria for applicants in awarding the parish grant:

1. Registered Member of the parish.
2. All family members regularly attend Sunday Mass.
3. Support of Parish through reportable income (offertory envelope, online giving or personal check).
4. Use of your time and talent to the various ministries and organizations within the parish.
5. Participate in the annual diocesan Catholic Sharing Appeal (C.S.A.).

In submitting this form, the applicant acknowledges that these criteria have been met and requests that the tuition grant be provided for the students listed below. The applicant should understand that if this grant is not awarded, or if the grant is awarded and subsequently revoked by the Pastor for failure to continue to meet the above criteria, the applicant will be required to pay the full tuition rate.
